Medium of Instruction

The medium of instruction and examination shall be English.

University Affiliation

All member colleges are currently affiliated to Kerala University of Health Sciences, Thrissur.

- Applications for admission to first year B.Sc. Nursing (Academic year 2025-26) in the 7 NRI category seats (Christian Community) at this college is being invited on the basis of this prospectus.
- 2. Seat matrix of the course

- 3. Academic Eligibility: To be eligible to apply for the B.Sc. Nursing course, the applicant must have completed and passed the 10 + 2 examination with 70% marks under the Kerala State Higher Secondary Board (Kerala HSC) OR Central Board of Secondary Education (CBSE) OR Indian School Certificate Examination (ICSE) after a period of 12 years study, the last two years of study comprising of physics, Chemistry and Biology with English at a level not less than the core course for English as prescribed by the National Council for Educational Research and Training (NCERT).
 - All applicants must have taken courses in science subjects; ie (Biology, Physics, Chemistry) and English from a recognized board/university (HSC, VHSE, ICSE,

- CBSE). The candidate have secured minimum of 70% of mark in Biology, Physics Chemistry and English at the Plus Two level.
- The student who completed secondary school educational qualification or equivalent obtained from any foreign country should accredited by the respective state/country and as such approved by the Association of Indian Universities and Kerala University of Health Sciences will be eligible for admission and Equivalency Certificate to this effect shall be produced.
- 4. Nationality: Candidates must be Citizens of India / children or dependents of Non Resident Indians.
- 5. Age Requirements: Applicants should complete 17 years of age on or before 31st December 2025. No relaxation of age will be allowed.
- 6. Eligibility for admission to N.R.I. Category Seats: According to the GO(MS) No.243/2014/H&FWD dated 06.08.2014, "An Applicant who depends upon his/her Father / Mother / Brothers and Sisters (inclusive of first cousins) / Husband / Wife / Brothers and Sisters (inclusive of first cousins) of Father or Mother / Half Brother / Half Sister / Adopted Father or Adopted Mother who is working abroad" will only be eligible to apply in the NRI category seats.
- 7. Copy of the following documents to prove the NRI status shall be submitted:
 - a) A candidate, who apply for the NRI seat should submit the passport copy and Visa/Green card/OCI documents of their respective sponsors attested by the Embassy or Consulate authorities. The job of the sponsor should be mentioned in any of the documents.
 - b) The visa of the sponsor should be valid till the closing date of admission in respect of the medical and allied courses.
 - c) In case, the employment of the sponsor is not mentioned in the above documents, the candidate has to produce the employment certificate of the sponsor attested by the Embassy/Consulate authorities.
 - d) The certificates clearly establishing the relationship of the sponsor with the candidate shall be obtained from the revenue authorities, as per the G.O(Ms) No. 243/14/H & FWD dated 06/08/2014.
 - e) However, the relationship between the candidate and his/her father/mother, which are recorded in the educational certificates, maintained in the usual course of transactions by the competent authorities, shall be accepted.
 - f) The candidate shall produce the sworn affidavit from the sponsor in a stamp paper worth Rs. 200/-. The same shall also be notarized by the Notary Public, disclosing that the student is dependent of the sponsor and the all expenses ie. tuition fee and special fee, of the candidate for the entire course period will be borne by the sponsor.
 - g) All the certificates/ documents required to establish NRI status shall be uploaded at the time of submission of application itself. The certificates/ documents produced later shall not be entertained under any circumstances.
 - h) The selected candidates should submit the above mentioned original documents at the time of admission

Note: Apart from the schedule of fees given above, the students will be required to pay the proportionate examination fee payable to the University from time to time. Hostel & Mess fee will be charged separately.

9. Scheme of Admission:

- i. Application Form will be available in college website: www nmcnursingcollege.ac.in (online).
- ii. Submit the filled online application form along with scanned copies of mark list, certificates, and details of application fee of Rs.1,500/- remitted to college account.
 (A/c No 31634554845 IFSC Code- SBIN0008652, SBI, Muvattupuzha via NEFT/RTGS)
- iii. The last date of online submission of application form will be on 20/08/2025. Late and incomplete applications will be rejected.
- iv. Scanned copies of the following documents shall be attached with the Application. (The originals documents will have to be submitted at the time of admission).
 - a) School Leaving Certificate (S.S.L.C.) of student establishing that the student has completed 17 years of age as on 31-12-2025.
 - b) HSCE or equivalent examination mark-sheet / pass certificate.
 - c) Proof for NRI status (Refr. no. 7 above).
 - d) A statement to show that the high school in which the student has studied has been accredited by the State/Country/University (if applicable).
 - e) Equivalence Certificate from Association of Indian Universities (if applicable).
 - f) Eligibility certificate from Kerala University of Health Sciences (if applicable).

10. Procedure of Rank list

The rank list for B.Sc Nursing will be prepared on the basis of the percentage of marks obtained in English, Physics, Chemistry and Biology (or equivalent science subjects) in the second year examination - qualifying examination.

11. "Candidates who express their intention not to pursue studies in the Nursing College before the last date fixed for closure of admissions will be eligible for refund of the 1st year tuition fee and other fees except admission fee. They will be eligible to get back their original certificates handed over to the College at the time of admission. In the case of students who leave the College midway, the right of the management for liquidated damages, if any, from such students will be determined by the competent "Civil Court."

- 13. All students who get selected should get themselves vaccinated against Hepatitis B before admission. A certificate to the effect shall be produced at the time of admission or before commencement of the course.
- 14. Code of Conduct :Every student is required to adhere strictly to the Code of Conduct of this college.

15. Prohibition of Ragging

- Ragging/any type of misconduct towards any student both in the college campus or
 outside will be considered as criminal offence and will be immediately reported to
 the police. Perpetrators will not be permitted to continue their studies.
- Every student shall, at the time of admission, furnish a character certificate from
 the institute wherefrom he/she has passed the qualifying Examination, which
 would mention the status of his/her behavioural pattern especially in terms as to
 whether he/she has displayed persistent violent, or aggressive behaviour or any
 desire to harm others.
- Students and parents shall, at the time of admission, furnish an affidavit to effect that the students will not indulge in any form of ragging.

16. Ragging is strictly prohibited. If it is found during the admission or any time there after that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the institution. Whoever commits, participate in, abets or propagate ragging within or outside the institution shall be suspended from the institution with immediate effect and the Principal shall report the matter to the civil/police authorities.

17. Without prejudice to the directions of the Nursing Councils/Government/University, the decision of Secretary, Nirmala Society for Medical Care, Nirmala Medical Centre, Muvattupuzha shall be final on all matters with regard to admission.
